it is true that the transition to this new model would cause some disruption in the market for old-fashioned media. but it would only disrupt the market by a tiny bit. the internet has completely changed the music and video industries in other ways, and it has taken time for the damage to be fully understood. new artists and new video and audio formats have arisen. music is cheaper. dvd sales have fallen. there has even been a new form of live performance, the "webcast," that has supplanted broadcast. thanks to the net, all these new products have existed for years, and thousands of them are already in place. indeed, many of the changes of recent years, including the development of hdtv, the introduction of the vcr, and the pc and internet, have raised more questions than they have answered. for example, lots of consumers still don't know how much of the content they own is in digital format. many of the things that we take for granted, like the ability to listen to music on demand or to instantly "borrow" a movie from a friend, did not exist when the internet became more than an academic concept. that is, they did not exist until decades of technological development in other areas and the introduction of a new technology enabled that development. if you're a television producer with a pet project, you may find that the internet has created a confusing landscape. you might find it difficult to reach an audience. you may find that this audience is a lot smaller than you expected. however, the nearly universal adoption of broadband internet and computer technology means that, unless the new internet-based technologies either fail or are replaced by other technologies, you cannot avoid the transition to digital media.

but there is a moral obligation, at the very least, to curb the harm done by the internet "piracy" industry. if we allow this industry to force consumers to pay a premium to download their videos and films, then that industry will keep those premium prices for far longer than they need to. the most important thing is to remind ourselves that movie and music videos are not, in and of themselves, valuable. in that respect, it makes no difference whether they are downloaded from reputable websites or

people rip them from a cracked movie cd. if they are really missing something, it's because we have not had good access to the music or videos. movie and music makers would not be losing anything if people would just stop downloading movies and music. it's as though the us government had to determine how much to charge for digital downloads of books, cds, and dvds. the movie and music industries would continue to get well-made movies and music made even better if people paid for them. it's not right to take people's personal property without giving them a

fair price for it. will that happen? the effects of digital movie piracy in the us are still relatively new and the government isn't entirely sure what impact it will have on the media industry. so the jury is still out. but, if we continue to let the internet piracy industry make that call for us, we will end up being subjected to downloads forever. let's hope we are not in that position. it's been fun, but let's keep watching . the system would be more effective as a deterrent to download cheaters if its first part--the checking of each site against the most recent local copy of the safe browsing

list--were delayed for a longer period of time, perhaps by several days. sometime over the course of the day, the tracker would send the first part of the partial url fingerprints to google for verification. at the same time it would send the second part to the selected members of the sample. only if the sites were verified to be on the list would each site receive an ok from google, so that the timer could complete and its statistics could be transmitted to the other members. (this is a classic case where the tracker is doing work outside of the sample: the work

has to be done separately because the members of the sample have inconsistent access to the sites on which they wish to check.) to filter out all the legitimate tracks during this phase would require a substantial number of false positives. in principle, this filtering might be done at the expense of accuracy, if the system included an option to reject a site if too many questionable sites had been checked, regardless of whether the list was negative or positive. another problem is that legitimate site administrators might sometimes voluntarily

change their urls. for example, some sites might have urls that include a hash as part of the fragment, since theyre using a url shortening service. google would need to be given a reasonable period of time to learn and update its list if many such services were to simultaneously change their urls, so the information that resulted from such a sudden alteration couldnt be taken at face value. google says it normally gets an updated list from automattic every tuesday and that on tuesdays at noon the server status page for google.com will be updated to

show how many sites have been checked. 5ec8ef588b
